Met with the Council of Churches, next Tuesday, Federici's is giving 10% of their sales to the Council of Churches. Surfer's Healing event was very inspirational. Council member Brennan: Attended the Environmental Commission meeting last week, discussed the bamboo problem in town; looking to copy Lake Como's ordinance. They are looking to complete the Treasure Trail. Also looking at getting our sustainable NJ rating back. School is back in swing.

Council member Nicolay: Thanked Gene Murray for the service on 9/11. Thanked the bathroom attendants for their work. Grand opening and dedication ceremony for the Silver Lake Monarch Inn is September 26th at 10:30 am.

PUBLIC SESSION:

Beth Rotchford, 1200 Bayview, stated she is trying to figure out how to repave 12th Avenue from the railroad tracks to River Road. Jaeger Lumber brings in an extreme amount of large truck traffic which she can feel shakes her house. Has done a lot of research about resurfacing roads to mitigate truck vibrations.

Mr. Campbell, DPW Director, stated it does need to be repaved.

Joan Corallo, A Street, stated there was an article in the newspaper about someone passing away from West Nile Virus. It talked about Monmouth County spraying nearby towns and asked about Belmar. Beach staff was outstanding. She asked why the northern end of town doesn't have one way streets during the summer. Police Chief Palmisano stated those streets are wide enough for cars to park on both sides and for two cars to drive past each other.

Jessica Wolculla, Dina Manor, suggested an amendment to the code enforcement inspection checklist regarding second floor condominium units. The issue is when second floor units don't have carpeting which is a violation of the condominium bylaws. The condo association has told her there is no town law to back it up so there is nothing they can do. She asked if a change can be made to the ordinance, she has seen other states who have an ordinance.

Claire Deicke, 1017 14th Avenue, thankful the San Genaro festival is continuing.

Brendan Reed, 100 Ninth Avenue, reminded everyone about the Historical Society's bootlegger's ball and upcoming events: Beer on the Pier and Battle of the Bag Pipes. Belmar monopoly sales will be starting soon.

Council member Nicolay stated the Belmar Pro and Kite Festival this past Sunday were really great.
