REPORTS OF COUNCIL:

Council member Magovern: Shade Tree Commission still working on Tree City designation. Town paper shredding event this past weekend was very successful. Congrats to Manasquan High School football champions. Neil Sterling had four receptions this past Sunday as Tight End for the Jacksonville Jaguars. Marina Mabrey who is on the Notre Dame team plays the No. 2 team tomorrow night.

Council member Keown-Blackburn: Tree lighting went wonderful. Plaza looks beautiful. Tomorrow evening the Library is having a historian speaking about Pearl Harbor. Senior luncheon is December 14th. St. Rose Grammar School will be performing at the luncheon. Anyone attending should bring an unwrapped toy. FEMA has awarded us \$800,000. PUBLIC SESSION:

Robert Forte, 114 8th Avenue, stated the food trucks this past summer looked tacky and violated the Borough's sign ordinance. Asked what the proposal is for next season now that the pavilions are built. Mayor Doherty stated we said all along that the food trucks were temporary. It is our intention that they will not be there in 2017, however that is not a unanimous decision of the Council. Mr. Forte asked if there will be lightning rods on the pavilions. Ms. Connolly stated she doesn't think so but would look into it. Mr. Forte discussed the Jersey City beach day and asked what we get in return for providing this event. Mayor Doherty stated it's to gain exposure for our town in Hudson County. Mr. Forte asked if it will be done for any other towns. Mayor Doherty stated not at this time.

Tom Volker, 527 8th Avenue, thankful that the jury sided with the police department on that lawsuit. Believes the police department probably saved her life. Thanked Council and DPW for the sidewalk program that's going on. Mayor Doherty and Mr. Volker talked about a successful BBP meeting and the possibility of a Chamber of Commerce being reinstated.

Lenny Klein, 306 11th Avenue, would like to get information on the sidewalk assessment program.

Council member Nicolay stated the Boy Scouts dropped off yellow bags at residences seeking canned goods to be donated to the food bank. Also mentioned the Santa toy delivery event for Belmar children.

Bruce Blattner, 407 9th Avenue, this Saturday the First Aid is having a blood drive, the 17th is their senior brunch and also on the 17th is the Fire Department toy event at the school.

Mayor Doherty made a motion to close the public session and adjourn the meeting, which was seconded by Council member Nicolay and approved unanimously.
