WORKSHOP DISCUSSION:

- Artificial Turf
 - O Mr. Cannon drafted an ordinance for introduction at the next meeting. The ordinance sets provisions for properties wishing to install artificial turf. There is a clause that states properties who have turf at the time of adoption of the ordinance would not have to comply with the ordinance. This would address the concerns from the residents who installed turf and spent a lot of money on it.
 - O Council member Magovern asked if someone could challenge the ordinance and install artificial turf in their front yard. Mr. Cannon stated anyone could challenge it but it would be enforced by the ordinance and how you would enforce any zoning regulations.
 - o Council member Brennan appreciated the work put into the ordinance and felt his concerns were addressed. He felt we should allow them to put it in their front yard if it meets the regulations.
 - o Council member Magovern was concerned about taking up too much grass and how it would affect animals and insects.
 - o Council member Walsifer agreed with Council member Brennan.
 - o Council member Nicolay stated she needs more time to review the ordinance. She was concerned about too much of the town having artificial turf.
 - Mr. Cannon stated a letter was sent out to individuals who have the turf by the Code Official indicating enforcement actions may be taken. Those letters will not be followed up with enforcement from the Code Official.

PUBLIC SESSION:

Ed Monte, 117 19th Avenue, satisfied with outcome of the artificial turf issue. Felt this whole matter was handled wrong and put a lot of people in distress. Felt there are bigger issues with the number of houses still boarded up from Hurricane Sandy and all the homes up for sale.

Leigh Kelsey O'Donnell, 604 Fifth Avenue, lives next to the Seaport Inlet Marina where the fire occurred. Was looking for updates on the property owner's requirements to implement safety measures by April 1st. Mayor Doherty stated the deadline of April 1st was to demolish the structure but the safety measures did not have a timetable.

Rick Adase, 413 13th Avenue, would like a copy of the proposed turf ordinance. Felt it would have been helpful if public comment was allowed during the workshop portion of the meeting.

George Komitas, 111 Third Avenue, stated the Police Department does a great job. Remembers when Council member Walsifer was sworn in.

Tom Dilberger, 1000 River Road, felt the code red about the storm last week wasn't an emergency. Felt the code reds are not needed. He asked Mayor Doherty if he would stop them. Mayor Doherty replied no. Council member Nicolay stated a lot of people were thankful for the reminders.

David Schneck, 302 C Street, asked if the outlet on the wall where he plugs in his video camera could be turned back on.

Angela Pheiffer, 319 Fifth Avenue, asked for a brief explanation of PILOT taxes vs regular property taxes. Mayor Doherty and Mr. Cannon explained. Ms. Pheiffer was concerned that there will be more of a burden on the school.

Steve Bloom, 1104 A Street, asked if people who want to install turf in their front yard would have to apply for a variance. Mayor Doherty stated they could do that.

Robin Monte, 117 19th Avenue, stated she didn't get a letter about her artificial turf and wants to make sure she won't have any issues.

Jason Rusak, Avon, owns an artificial turf company. Suggested a specific type of turf or a vendor be listed in the ordinance. Mr. Cannon stated we cannot do that.

Mayor Doherty made a motion to close the public session and adjourn the meeting, which was seconded by Council member Brennan and approved unanimously.
