PUBLIC SESSION:

Peter Piro, North Blvd., asked when the ordinance will be amended to reflect 19th Avenue will be one way westbound. Ms. Connolly stated it is on our to do list for January. Mr. Piro asked about the Lake Como pipe work. Ms. Connolly stated they will be working on North Blvd. in January and Ocean Avenue in March with a completion date by Memorial Day.

Nancy Koenig, 303 C Street, asked what kind of trees were planted at Silver Lake. Council member Magovern stated they were Japanese Lilac.

Linda Labuff, 1719 River Road, stated she has an issue with her neighbor who has bamboo that has grown into her yard. Spoke to Code Enforcement and they said there is nothing they can do. She felt this was unfair. Council member Brennan stated the ordinance clearly reads that bamboo cannot encroach onto neighboring properties and the neighbor should have to remove it. Ms. Connolly will speak to Code Enforcement and contact Ms. Labuff.

Council member Magovern made a motion to close the public session and adjourn the meeting, which was seconded by Council member Walsifer and approved unanimously.
