WORKSHOP DISCUSSION:

- Historical Society photo presentation of the return of the Doughboy Statue
- Main Street Bridge
 - o Mayor Magovern discussed the repairs or reconstruction of the Main Street Bridge that have been happening. Recalled the bridge would not be closed during these changes, however we received a letter that the bridge will be closed after September for two months for some time to fix guardrails. Doesn't understand why they would be making these repairs when the bridge will be torn down in three to four years. Would like to work with Avon to send letters to DOT showing our disapproval of this and ask for an explanation.
 - o Council member Nicolay agreed it would be better to have more explanation and possibly push it back because September is still busy.
 - Council member Brennan stated there were two meetings on the bridge and it was discussed the affect the last time the bridge was closed had on both towns. Feels DOT isn't doing what they told us they would do.
 - Council member Walsifer agreed we need to send a letter. Is it a public safety issue that needs to be addressed in September? Sounds like one section of DOT is not communicating with another
 - Council member Levis would like to see what they are doing. Doesn't understand why they would need to close the bridge for guardrails unless there are mechanical issues. Will be a big headache for the businesses on Main Street.
- Mayor Magovern asked for an update on the lights on Main Street north of 10th Avenue. Ms. Connolly stated they are working with Maser to correct the problem and have the lights turned on before Christmas if not before then.
- Council member Levis stated he heard from some residents a suggestion to form a Parks Commission to handle maintenance and improvements to all the parks. Felt it would be a good idea. The Mayor and other Council members thought it could be a good idea.

Rose Dagayna, 201 9th Avenue, asked who determines building height in a town. Mr. Cannon explained it's listed in our Master plan, redevelopment plans and zoning ordinances. She was concerned about over development and over populating Belmar. She is not happy with the plans for Borough Hall and the development on Tenth Avenue. Mr. Cannon explained the zoning board process. She also asked if we could lower the age for beach badges and adjust the fees to be like other towns.

John Magrini, Mayor of Avon, stated they are equally as concerned about closing the Main Street bridge. Want to oppose it as much as we can.
