WORKSHOP DISCUSSION:

- Mayor Walsifer announced that Chief Andrew Huisman will be retiring at the end of the year. Chief Huisman gave a brief speech, thanked all the Officers who have made his job easier. Thanked the past and current Mayor and Councils and Administrators he has worked with over the years. Thanked Captain Scott, Captain Cox, Lieutenant Mike Campbell, his assistant Kim VanPelt and all the current Officers. Thanked his wife Lisa and his three sons for their support and patience. Mr. Kirschenbaum stated he has a long good working relationship with Chief Huisman throughout his own career. He added it's been a privilege and honor to work with the Chief.
- Mayor Walsifer stated we had a lot of discussion at the last meeting regarding the 9th Avenue project. Christine Bell, Borough's Planner, stated we have decided the project will be 3 stories, maximum of 36 ft and a setback of 40 feet in the back portion close to the residential properties. It will then step up to the 46 feet as it gets closer to Main Street. Feels this plan is the best option vs. the underlying zoning or the seaport redevelopment plan.
- Mayor Walsifer stated we have a resolution on the agenda for an emergency appropriation which is for two lawsuits where a judge awarded attorney fees of \$219,000.
- Mayor Walsifer stated there is also a resolution for the Newman redevelopment project. Mr. Dasti stated about 2-3 years ago the Council adopted ordinances to put this area into the redevelopment zone. We are now at the stage of adopting a Redevelopment Agreement.

REPORTS OF COUNCIL:

Councilman Carvelli: Attended final BBP meeting for 2019, working on 2020 budget and event schedule. Attended Christmas tree lighting which was well attended. Participated in Youth Government Day. Wished everyone a happy and safe holiday.

Councilwoman Wann: Shelter at Maclearie Park is under construction.

Councilman Brennan: Harbor Commission met last week and will recommend raising fuel prices and establishing monthly fees for the Fall. Attended the Borough holiday park which was a great event. Christmas tree lighting was a nice event. Attended Youth Government Day. Wished everyone the best of holidays. Jade Glab made it through the first round of Miss America.

Mayor Walsifer: Thanked Mike Campbell, Chief Huisman and the Fire Department for the Christmas tree lighting. Also attended Youth Government, nice to see the kids wanting to get involved. Wished everyone happy holidays and happy new year.

<u>PUBLIC SESSION</u>: Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.

Gene Creamer, 4th Avenue, asked for clarification on Resolution 2019-228. He stated on page 40 of the redevelopment agreement for Resolution 2019-222 it had the wrong Administrator listed. Mr. Dasti stated he already fixed that. Mr. Creamer asked about the Affordable Housing contribution listed in the agreement. He wanted to make sure redevelopment projects are not excluded from complying with the new Affordable Housing ordinance.

Katrina Clapsis, B Street, asked if there is a PILOT for the redevelopment agreement. Mayor Walsifer stated we took the PILOT out. Mr. Dasti explained they have negotiated a tax payment agreement where conventional taxes will be paid and phased in as construction is completed.

Elaine Giordano, 605 9th Avenue, asked about Ordinance 2019-35. Mayor Walsifer stated the public hearing will be later.

Councilman Brennan made a motion to close the public session, which was seconded by Councilwoman Wann and approved unanimously.

ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF BELMAR, COUNTY OF MONMOUTH, STATE OF NEW JERSEY, DETERMINING THAT THE REDEVELOPMENT PLAN PRESENTED TO THE PLANNING BOARD IS ACCEPTABLE AND THEREFORE THE SUBJECT PROPERTY SHOULD BE REZONED ACCORDINGLY

Public Hearing: Brett Lomas, 609 9th Avenue is thankful for the height being reduced in the one section. Glad moving in the right direction. Felt developers shouldn't be able to strong arm the Mayor and Council. Felt this project couldn't be built under the current commercial zoning without variances. Felt the property is being rezoned to avoid variances. The project is an increase in density and creates a parking issue. There are other projects that can be built there with less density.

Elaine Giordano, 605 9th Avenue, feels we are heading in the wrong direction with this. Linda Sharkus, 400 4th Avenue, stated the Council was going to bring redevelopment under control. If this is allowed to go through will there be more four-story development along Main Street.

Gene Creamer, 4th Avenue, stated keeping the existing zoning is a hollow threat.

Rose Dagyna, 201 9th Avenue, would like the Council to relook at the zoning and the Seaport Redevelopment Plan because its not working for the residents.

Martha Maselko, 102 North Blvd., supports the previous speakers and asked the Mayor and Council to listen to them.

Paul Marino, 112 9th Avenue, asked if anyone has an idea where we can meet in the middle.

Councilwoman Wann made a motion to close the public hearing, which was seconded by Councilman Brennan and approved unanimously.

Mayor Walsifer made a motion to adopt Ordinance 2019-35, which was seconded by Councilman Carvelli.

Councilwoman Wann voted in favor of the ordinance. She stated her concerns were with parking and height at the Planning Board. They heard what the people wanted and adjusted the height.

Councilman Brennan stated he has seen a lot of redevelopment projects come through, but this is the first time with so much public input. Mayor Walsifer has done a good job listening to the residents and the developer has made changes. Have to work out what most people can live with so we can move forward together. His concerns were the number of units and parking but that hasn't been addressed. He voted "no" on the ordinance.

Mayor Walsifer stated with the recommendations from the Planning and Engineer he voted in favor of the ordinance.

Councilman Carvelli stated everyone's concerns have been heard. We have looked at the plan, the CBD1 zoning and the Seaport Redevelopment Plan. Believes this plan is a compromise. It is a good project for Main Street. What is being approved tonight is different than what was presented to the Planning Board. He voted in favor of the ordinance.

PUBLIC SESSION:

Mark Kirschenbaum, West Belmar, asked if anyone on the Board is allowed to call someone at home and threaten them by stating they cannot come to a Council meeting to speak. Mayor Walsifer stated this is a public meeting and anyone can come speak. Mr. Kirschenbaum questioned the tax revaluation that was done years ago. He asked if employees get discounts on boat slips. Mayor Walsifer replied no, they pay the same as everyone else. Mr. Kirschenbaum asked why Bob Ferguson was hired. Mayor Walsifer stated he is a volunteer that gets paid \$1 per a year and does a lot of research for us.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Mayor Walsifer and approved unanimously.
