Sandy Caputo, Surf Avenue, thanked the Mayor and Council and everyone for using the microphones. She would like to see the microphones used for next week's zoning board meeting.

Linda Sharkus, 4th Avenue, thankful for the change to the animal house ordinance. Seems to have made an improvement particularly in the 400 block of 10th Avenue and the 500 block of 13th Avenue.

Gerald Buccafusco, 409 5th Avenue, asked about the beach reports because he hasn't seen any on the website. Mayor Walsifer stated the employee that handles them has been out of the office, but we will get them up. Mr. Buccafusco asked how the company that provides the software for beach badges gets paid. Mr. Kirschenbaum stated the user pays them. Mr. Buccafusco asked if this is permitted by the state. Mr. Varga stated it is, it's a contract agreement. Mr. Buccafusco would like to know how much the company has been paid. Mr. Buccafusco referenced the Mayor's letter sent with the tax bills. The letter stated the debt was cut in half. He questioned if the debt has been reduced by 17 million in the past two years. Mayor Walsifer replied yes. Mr. Buccafusco stated he could not find anywhere that said the debt was 39 million and where we got the money to pay down the 17 million. He would like to have the information at the next meeting or sit down with someone in finance to get clarification.

Cheri Russo, 1218 Briarwood, sent an email asking to volunteer and would like to meet with Ed about it because she didn't receive a response. Mr. Kirschenbaum stated we aren't doing the friendship force right now but will look into it.

Councilman Carvelli made a motion to close the public session and adjourn the meeting, which was seconded by Councilman McCracken and approved unanimously.
