WORKSHOP DISCUSSION:

- Redevelopment Report Borough Planner Dave Roberts
 - Met with Redevelopment Committee during their process. Discussed how the redevelopment plan came about in the late 90's, early 2000's. Reviewed Committee's report and feels it's a good foundation to move forward with working on a new redevelopment plan.
 - Mayor Doherty stated there are properties south of the redevelopment zone that want to be in a redevelopment zone so they can take advantages of some of the benefits that would be provided to them
 - o Mayor Doherty and Council member Brennan liked the one idea in the report that suggested creating several different zones. Council member Brennan also liked their suggestion regarding making the downtown pedestrian friendly.
 - Mr. Roberts gave suggestions on what the Mayor and Council can do with the existing redevelopment plan such as: rewriting the whole plan, keeping it and make changes, add new sections to it or any combination of these. He feels it's a great time to look at the plan and make changes.
 - Council member Magovern liked their idea of parking garages. He also stated their report talked about tax abatements. Mr. Roberts gave an explanation on tax abatements for a redevelopment zone.
 - Council member Magovern and Brennan discussed reviewing and amending the sustainability sections of the plan. Mr. Roberts suggested reviewing the sustainability checklist.
 - Council member Keown-Blackburn would like to make sure parking is addressed if the plan is going to permit more residential units above the commercial units. She liked their suggestion of adding more signage in the marina to encourage people to use the river walk underneath the bridge to get to Main Street.
- Energy Aggregation Ron Nowak, Maser Consulting, PowerPoint Presentation
 - Residents would be given the option to choose from a third party supplier for their electric bill.
 Borough would have to aggregate the whole town to allow residents to have purchasing power.
 Would give residents a savings of 10-30%. Mr. Nowak explained the process.

REPORTS OF COUNCIL:

Council member Magovern: Attended Historical Society's preopening, it's a great museum. They have done a great job cataloging Belmar's history. Planning Board member Chris Hoffman was reappointed at their last meeting, he is 78 years old and is a great resident and extremely knowledge. Saw DPW building new lifeguard stands for this summer, which are really nice. Swans that were removed from the lake have been rehabilitated and moved to a new lake. Congratulated Steve Woelfer, Environmental Commission, on participating in the Polar Bean Plunge for ALS this past weekend.

Council member Brennan: Wished everyone a happy mardi gras. Attended Environmental Commission meeting last week. They discussed possibly looking into an ordinance to regulate bamboo. They are looking to update the Treasure Trail as well.

Council member Keown-Blackburn: Senior luncheon last week was well done. Thanked the Library for speaking at the luncheon and Ma's for providing the food. Library is looking for people to ride on their float in the St. Patrick's Day Parade. February is Black History Month and the Library is showing a movie each week. Bicycle Pedestrian Safety Committee is meeting once a month. Walking in the gym is available on Tuesdays and Thursdays. February is also heart month and asked that everyone eat healthy and exercise.

Mayor Doherty: Moody's rating agency removed negative outlook on the Borough's rating and listed us as stable. Their report deemed the Borough fiscally responsible. Thanked everyone who attended the Home by Summer kickoff. To date we are a little under \$40,000. Belmar Fishing Club is hosting a fundraiser March 14th for Home by Summer. DeCarlo Fitness is going to do a Zumbathon fundraiser in April in the gym for Home by Summer as well. People from all over the country have donated into the PayPal account. March 1st is the St. Patrick's Day Parade. Appreciates everyone who has been removing snow from their sidewalks. Senior citizens who need help can call Borough Hall and we will try get them assistance.

PUBLIC SESSION:

Bruce Blattner, 407 Ninth Avenue, this Sunday is the Polar Bear Plunge for the Belmar Beach Patrol & cancer awareness.

Don Griffin, 817 13th Avenue, used to live near Silver Lake. Heard about town's plans to expand metered parking. Applauds town's efforts to pursue revenue generation. Asked where we have fallen short in revenue. Mayor Doherty stated we have not fallen short but are looking for ways to increase revenue without increasing property taxes. Willing to entertain other ideas. Mr. Griffin stated he would be in favor in putting the meters back on the west side of Ocean Avenue, however is concerned about expanding the metered parking to side streets. Feels the metered parking will have a negative effect on beach attendance from seniors and families with

children. Also feels it's increasing the expense for a local family to go to the beach.

Mayor Doherty stated the west side of Ocean Avenue was always on the books for metering. He added that the spots we are looking to meter are not in front of someone's home except for those on Ocean Avenue.

Frank Giannici, 5 Ocean Avenue, stated the spots are in front of people's homes; there are condos and apartments on Ocean Avenue. They only get one parking spot on their property and most people have more than one car. This will be an added expense to the people who live in these buildings or they will have to park further away. He suggested increasing the parking fees instead.

Tom Dilberger, 1000 River Road, stated he knows some of the taxi guys and there are companies coming in from out of town without a license and they need to be addressed.

Ted Ehmann, 1218 Oakwood Road, stated Hurricane Sandy had nothing to do with the Borough establishing a rehab area. It was done based on a report by the engineer that said our water/sewer infrastructure was in need of repair.

Mike Seebeck, 110 Second Avenue, asked if the redevelopment committee report is available online. Asked if we looked into rolling two of our bonds into longer term financing. Mayor Doherty stated we can't because there is FEMA money involved.

Joy DeSanctis, 101 Sixth Avenue, thinks the meters are a good idea, good way to generate revenue. National Street USA is an organization that the Redevelopment Committee should look into.

George Komitas, 111 Third Avenue, stated Sean McGrath is a great person and runs a great surf camp. Congratulated Council member Brennan.

Gene Creamer, Fourth Avenue, asked if we have a Borough flag. Mr. Komitas stated they were taken down due to the wind.

Raymond Miller, Off the Boards -1000 Ocean Avenue, stated he would like to lease a few parking spaces in front of his store so his customers can come in and look at the artwork that he has on display.

Mayor Doherty made a motion to close the public session and adjourn the meeting, which was seconded by Council member Keown-Blackburn and approved unanimously.
