

ORDINANCE NO. 2017-22

ORDINANCE OF THE BOROUGH OF BELMAR AMENDING THE REVISED GENERAL ORDINANCE CHAPTER 19: "TRAFFIC" TO CORRECT AN ERROR IN SECTION 20: "THROUGH STREETS" AND TO DESIGNATE CERTAIN "SEASONAL" ONE-WAY STREETS AS "YEAR-ROUND" ONE-WAY STREETS PER ENGINEERING ANALYSIS AND DIRECTIVES FROM MONMOUTH COUNTY

BE IT ORDAINED by the Mayor and Council of the Borough of Belmar, County of Monmouth, State of New Jersey, that Chapter 19: "Traffic" of the Borough's Revised General Ordinances is hereby amended as follows (~~stricken text~~ indicates deletions, underlined text indicates additions):

19-20 THROUGH STREETS.

Pursuant to the provisions of N.J.S.A. 39:4-140, the streets or parts of streets described are hereby designated as Through Streets. Stop signs shall be installed on the near-right side of each street intersecting the Through Street except where Yield signs are provided for in the designation.

19-24 ONE-WAY STREETS.

- a. **Year Round.** The following described streets or parts of streets are hereby designated as One-Way Streets in the direction indicated. Parking on these streets will be permitted on the sides indicated below.

"A" Street	Northbound	North Boulevard to South Lake Drive and starting at a point approximately 175 feet north of the intersection of Fifth Avenue and "A" Street to First Avenue.

Belmar Marina	Northbound	Belmar point at extension of Ninth Avenue along bulkhead loading zone to point at extension of Eighth Avenue.

"E" Street	Northbound	Sixteenth Avenue to Fifth Avenue.

BE IT FURTHER ORDAINED that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only.

BE IT FURTHER ORDAINED that this ordinance shall be in full force and take effect twenty (20) days after final passage and publication, as required by law.
