RESOLUTION AUTHORIZING ISSUANCE OF PLENARY RETAIL CONSUMPTION LICENSE TO KLEIN'S FISH MARKET, INC. FOR THE PERIOD ENDING JUNE 30, 2019

WHEREAS, application has been made for a Plenary Retail Consumption License No. 1306-33-008-009 by Klein's Fish Market, Inc. for the premises at 702,704 and 708 River Road, Belmar, N.J.; and

WHEREAS, said application is accompanied by an Affidavit of Publication and reports from Chief of Police and reports from Borough Inspection Officials, and Fire Official if applicable; and

WHEREAS, the use of this license is to provide alcoholic beverages to dining room customers. A live music area is limited to two or three musicians from 6PM-10PM; that the entertainment be for seated customers only, with no standing audience; and that there be no music allowed after 10PM. Must comply with floor plan approved by Mayor & Council.

1. It is a requirement that all employees licensed to handle alcoholic beverages undergo TAMS training within 30 days of being hired; records of this requirement are to be maintained by the licensee.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council that a Plenary Retail Consumption License for the period from July 1, 2018 to June 30, 2019 both dates inclusive, be issued to Klein's Fish Market, Inc. subject to the Special Condition that no alcoholic beverages shall be sold, served, delivered to, or consumed in the license premises during such time as the number of persons, exclusive of employees, occupying the licenses premises exceeds the occupancy limit established by the Fire Official.

Occupancy: The premises at 702,704 and 708 River Road Occupancy is limited to 223 persons inside dining, outside dining area 440 persons.

BE IT FURTHER RESOLVED that the Borough Clerk be and is authorized to sign and deliver license certificate to said applicant.

WHEREAS, on April 20, 2017, the Borough of Belmar (the "Borough") entered into a Lease Agreement with M2 Concessions, LLC for the Fifth Avenue Pavilion Concession Area; and

WHEREAS, on April 28, 2017, the Borough entered into a Lease Agreement with Hilary Colanduoni and 10th Avenue Freeze Out, LLC for the Tenth Avenue Pavilion Concession Area South End; and

WHEREAS, since the execution of the respective Lease Agreements, the concessionaires have brought to the Borough's attention certain aspects of their Lease Agreements that should be clarified to enhance their existing operations; and

WHEREAS, the Mayor and Borough Council find that it is also in the Borough's best interests to clarify and more specifically define the concessionaires' rights and obligations to avoid potential conflicts with its tenants in the future;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Belmar that:

- 1) The Lease Addendum to the Borough's Lease Agreement with M2 Concessions, LLC, which is attached hereto as Exhibit A, is hereby approved by the Mayor and Borough Council.
- 2) The Lease Addendum to the Borough's Lease Agreement with Hilary Colanduoni and 10th Avenue Freeze Out, LLC, which is attached hereto as Exhibit B, is hereby approved by the Mayor and Borough Council.
- 3) The Borough Administrator is hereby authorized by the Mayor and Borough Council to execute and deliver to the concessionaires their respective Lease Addendums and to take such measures as may be necessary to implement the terms and conditions thereof.

FIRST ADDENDUM TO LEASE AGREEMENT, DATED APRIL 28, 2017, BETWEEN THE BOROUGH OF BELMAR AND HILARY COLANDUONI AND 10TH AVENUE FREEZE OUT, LLC

WHEREAS, on April 28, 2017, the Borough of Belmar ("Landlord") and Hilary Colanduoni and 10th Avenue Freeze Out, LLC ("Tenant") (collectively, the "Parties") entered into a Lease Agreement for the Tenth Avenue Pavilion Concession Area South End; and

WHEREAS, the Parties desire to clarify and modify certain terms and conditions contained in the Lease Agreement to more specifically define their respective rights and obligations and to avoid potential conflicts in the future;

NOW, THEREFORE, the Parties hereby covenant and agree as follows:

- 1) Paragraph 2 of the Parties' Lease Agreement shall be amended to indicate that: "The Property to be leased constitutes that portion of the south end of Tenth Avenue Pavilion locate at Tenth Avenue on the boardwalk in Belmar, New Jersey, comprising 800 square feet."
- 2) Paragraph 7 of the Parties' Lease Agreement shall be amended to include a paragraph (A) stating as follows: "Notwithstanding any provision contained herein to the contrary, Tenant shall be permitted to set up an outdoor eating area with a tent structure, in the location described and as depicted in Exhibit A attached hereto, until October 31, 2018. On or before November 1, 2018, Tenant shall completely remove all tent frames, coverings, attachments, lashings, or other tent components of whatever form or description from the Property. While erected, all tent frame components supported by the ground must be clearly visible to pedestrians and other passersby so as not to constitute a safety hazard and Landlord's Zoning Officer may require a decorative chain or other means to ensure visibility of frame components supported by the ground. Graphic content on the tent structure shall conform to the requirements for canopies under 40-7.24, Schedule 40.7-1 and Zone District Requirements of the Borough of Belmar. Except for permitted construction or repair of the tent, at no time shall Tenant be permitted to remove the tent covering and leave bare frame components visible."
- 3) Paragraph 8 of the Parties' Lease Agreement shall be amended to state as follows: "The Tenant agrees to use the Property only for the purpose of sale of food products, beverages, ice cream, frozen yogurt, frozen fruit products or other dessert products. The Tenant shall operate its business and be open for business, at minimum, from May 15th through September 15th of each year. The Tenant may otherwise be open for business at the Property at its discretion, and Landlord shall not require the Tenant to operate year-round."
- 4) Tenant shall be permitted to set up an area near its business on Landlord's beachfront in accordance with the provisions of Belmar Borough Ordinance No. 40-7.32.2 that are applicable to "Outdoor Eating Areas", provided however, that the public may not be excluded from said area, regardless of whether or not such persons are patrons or customers of Tenant's business.

FIRST ADDENDUM TO LEASE AGREEMENT, DATED APRIL 20, 2017, BETWEEN THE BOROUGH OF BELMAR AND M2 CONCESSIONS, LLC

WHEREAS, on April 20, 2017, the Borough of Belmar ("Landlord") and M2 Concessions, LLC ("Tenant") (collectively, the "Parties") entered into a Lease Agreement for the Tenth Avenue Pavilion Concession Area North End; and

WHEREAS, the Parties desire to clarify and modify certain terms and conditions contained in the Lease Agreement to more specifically define their respective rights and obligations and to avoid potential conflicts in the future;

NOW, THEREFORE, the Parties hereby covenant and agree as follows:

- Paragraph 8 of the Parties' Lease Agreement shall be amended to state as follows: "The Tenant agrees to use the Property only for the purpose of sale of food products, beverages, ice cream, frozen yogurt, frozen fruit products or other dessert products. The Tenant shall operate its business and be open for business, at minimum, from May 15th through September 15th of each year. The Tenant may otherwise be open for business at the Property at its discretion, and Landlord shall not require the Tenant to operate year-round."
- 2) Tenant shall be permitted to set up an area near its business on Landlord's beachfront in accordance with the provisions of Belmar Borough Ordinance No. 40-7.32.2 that are applicable to "Outdoor Eating Areas", provided however, that the public may not be excluded from said area, regardless of whether or not such persons are patrons or customers of Tenant's business.
