<u>APPROVAL OF MINUTES</u>: Councilman Brennan made a motion to approve the February 19, 2019 meeting minutes, which was seconded by Councilman Carvelli and approved unanimously.

REPORTS OF COUNCIL:

Councilman Carvelli: Belmar Senior Luncheon is March 13th at Taylor Pavilion.

Councilman McCracken: Shade Tree Commission had its first meeting last week. Seeking additional members. Belmar Housing Authority met last night; now accepting applications.

Councilman Brennan: Working on vendors for Seafood Festival. Attended a NJCAR meeting and received some very good information we can use regarding disaster recovery. Also attended a budget meeting for elected officials. St. Patrick's Day parade was outstanding. Kudos to DPW on cleanup afterwards. Proud of Belmar students for doing a great job in the parade. Bella Serano won the state championship in girls wrestling.

Mayor Walsifer: Parade was very nice, thanked all those who helped coordinate it. Attended the 125th anniversary of Hook and Ladder. PBA Valor Awards were given to Larry Kelly and Kevin Jones.

<u>PUBLIC SESSION</u>: Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.

Joan Corallo, A Street, asked about the Cranford Cooperative pricing agreement. Mr. Dasti stated it allows us to get the best price to purchase police items.

Steve Lemoine, 403 C Street, asked about the marina parking spaces. Mayor Walsifer stated it is ten additional spots. Mr. Lemoine asked about the Tourism Commission, does it cost any money. Mayor Walsifer stated it does not, we are just adding two additional members. Mr. Lemoine asked if we want to lock in a DPW Director for four years. Mr. Schlager stated it is an at will contract.

Councilman Carvelli stated he is still doing research and will report it when has some more information to share.

Geri Pitocco, 205 2nd Avenue, asked if the website can be updated while we are waiting for a new one.

Cy Reitmeyer, 5th Avenue, asked when the budget will be done and who formulates it. Mayor Walsifer stated the CFO and Auditor will prepare it. Mr. Reitmeyer stated the parade cleanup was very good, asked who paid for the county vehicles to help out. Mayor Walsifer stated it is a volunteered shared service. Mr. Kirschenbaum stated the out of town police officers are volunteered as well. Mr. Reitmeyer questioned plowing of slush. Mr.

Kirschenbaum stated there is a reason to plow slush, it could turn to ice and be unsafe. Mr. Reitmeyer asked for an update on the pavilions. Mayor Walsifer stated there is a meeting tomorrow to determine what needs to be done to get the 10th Avenue Pavilion up and running. Asked about the Lake Como project as well. Mr. Dasti stated we will meet with the DAG in a few weeks to discuss further.

Eileen Thiede, 210 10th Avenue, came back in June, water meter hasn't worked for three years. Doesn't think should be penalized for the meter being old and doesn't think she should have to pay for a new one.

Elaine Giordano, 605 9th Avenue, sent a letter to the Mayor and Council and would like to read her letter at a future public meeting. Would like it made public how many PILOTs we have agreed to, how long are they for, and how many are still to come.

Councilman Brennan announced this weekend the Drama Club is presenting High School Musical.
