WORKSHOP DISCUSSION:

- Mayor Magovern announced that Police Chief Drew Huisman has been Acting Business Administrator since Colleen Connolly's resignation.
- Frank Kelly spoke regarding the JIF renewal. Informed the Mayor and Council it is time to renew with them. They will be working to get us in the best JIF for the best price. There will be a savings in 2019 while coverage will stay the same. They explained the positives of being a member of a JIF. Mayor Walsifer asked why we are not part of the Monmouth County JIF. Mr. Kelly stated we have had some good experiences with the Central Jersey JIF. Both are part of the MEL System anyways and you can compete against each other. They discussed the safety meetings and the training and controls in place to ensure the safety of Borough employees. Mike Campbell, DPW Director, stated they handle the Borough's JIF and have recommended we go into the Monmouth County JIF because the Central Jersey JIF doesn't have small beach communities like us. They always must drive to Woodbridge for the meetings and the issues discussed are not relevant to that of a small community. Council member Nicolay asked if there are any negatives to changing. The filings with the JIF are done every three years, the deadline to switch may have passed. Could probably have the employees participate in the Monmouth County safety meetings as an alternative. Mr. Kelly stated the savings the Borough would get are contingent on signing a three-year renewal. He would not know if those savings would be the same for Monmouth County. They will investigate it.

Councilman McCracken: Terri Pierce passed away this week. She was very dedicated to Belmar. Keep her and her family in your prayers.

Councilman Walsifer: Wished everyone a happy new year.

Councilman Brennan: Dune growing project along the boardwalk had another installation near 4th and 5th Avenue beach. The dune grass was purchased through the grant for the Lake Como project, but residents didn't want it planted near the lake. Eventually will plant regular grass and walkways there. For now, the dune grass will be used elsewhere as we find places to put it. Thanked DPW for doing a great job with the plantings. Will investigate grant funding to do more plantings. Thanked Councilwoman Nicolay and Mayor Magovern for all their years of service, particularly after Hurricane Sandy.

Councilwoman Nicolay: Thanked DPW, police, Mayor Doherty, Claire Deicke, Janis-Keown-Blackburn, Mayor Magovern and Councilman Brennan for all their work and assistance during her time on the Council. Some highlights from her time on the Council: hurricane sandy recovery, boardwalk reconstruction, Taylor Pavilion reconstruction, summer camp, new playgrounds, Lake Como pipe, youth club, community center, no more brown water in areas of town. Will always be proud to be a part of a great team.

Mayor Magovern: Thanked Police Department for a great job and a safe year for the residents. Thanked DPW for doing such a great job. Also thanked the Fire Department for their work. Hopes the Fire Department budget

will be increased in 2019, they need new equipment and repairs to the firehouses. Thanked the First Aid for all their work and efforts.
