WORKSHOP DISCUSSION:

- Jet Ski and Kayak Rental Rates for 2019
 - Bob Lynch of the Harbor Commission stated our rates are lower than a lot of other places and there is a high demand for rentals. Suggested increasing the out of town rate and keep the Belmar rate the same
 - o Council member Nicolay suggested adding kayak storage on the beach for those that take theirs out into the ocean. Would like to keep it family friendly and affordable.
 - o Mayor Magovern was concerned about chasing away renters if the rates are raised.
 - o Council member Walsifer stated he is in favor of raising the nonresident fee.
 - o Council member McCracken asked if residents have priority on the waiting list. Mr. Lynch replied no, it's first come first serve.
 - o Council member Brennan remembered when he was on the Harbor Commission they had decided to keep rates low to attract renters with the intention to raise the rates eventually.
 - o Mr. Lynch stated the Harbor Commission has been discussing whether to raise other fees.
- Kerry White and Johanna Roper-Robinson from the Library Board were present to discuss some things they need to do so the Board is following state regulations. The Mayor or a Council member should be present at their meetings. Community Center has been hosting many of their events and they hope that continues. Ms. Connolly stated the lease has been extended through June 30, 2019. They should have a full-time director, a treasurer, a bookkeeper, and their own funds.
 - O Council members Nicolay and Brennan stated the Library does a great job with their programs and activities. Council member Walsifer agreed. Council member McCracken would like to see the feasibility study when it is completed. Mayor Magovern stated his father was a fan of the library and would be pleased to see how far it has come.
- Chris Brandl of Brandl Restaurant would like to store a vehicle in the Plaza near his building. He has decorated it for the holiday and thought it could be a good photo op. Mayor Magovern was concerned about other people decorating their vehicles and parking them on public property or at one of the parks. Council member Nicolay stated she likes it and thinks it would be interesting. Mr. Cannon stated Mayor Magovern is correct that if this were allowed other businesses might want to do it as well. He was concerned that this may have to be bid out to allow other businesses the option. He felt there needs to be more discussion and research on this. Captain Cox of the Police Department stated they would oppose the vehicle being in the Plaza because of security concerns. Council member Walsifer felt this should be done through a special event application like the antique car shows. Mr. Brandl stated he was just looking to do something different but doesn't want to make it a big ordeal out of it.

APPROVAL OF MINUTES: Council member Nicolay made a motion to approve the November 20, 2018 meeting minute, which was seconded by Council member Brennan and approved unanimously.

REPORTS OF COUNCIL:

Council member McCracken: Attended the Menorah lighting last night, which was well attended.

Council member Walsifer: Harbor Commission discussed there are six or eight parking spots near the fuel pump they would like designated for boat owners. Mayor Magovern suggested looking into some shared parking in the trailer parking area between the boat owners and restaurant goers.

Council member Brennan: The Menorah lighting was lovely. Thanked Chris Brandl and DPW for their work. This past Saturday attended a program at the Library that was very well attended. The presentation was about climate change and it was very disturbing information on what's going to happen in the future. He gave some highlights from the presentation.

Council member Nicolay: Belmar Arts Council has an Affordable Art exhibit going on right now. The Santa toy delivery will be on December 18th and 19th. Next Thursday is the Belmar School Holiday Concert.

Mayor Magovern: The Shade Tree Commission has qualified the Borough for the third year in a row to be a Tree City. The Christmas Tree Lighting is this Friday at 5:30 pm in Pyanoe Plaza.
