WORKSHOP DISCUSSION:

Mr. Kirschenbaum gave an update on COVID-19. All information is being posted a specific page on our website. Borough Hall is closed but there is a mail slot for people to drop off payments. Working with the County and State to follow new regulations. Mayor Walsifer stated the Boat Show and Easter Egg Hunt have been cancelled.

Mayor Walsifer stated that at the last meeting a resident made an allegation of a pay to play violation. Mr. Dasti explained he reviewed the ordinance and ELEC laws. He also spoke to the State Republican Committee. The issue is the State Republican Committee sends out flyers listing statewide candidates and asking for their votes. It specifically says on the card that they are not supported by one specific candidate. The candidates are unaware this is going on. It would be considered an in-kind contribution, which the Mayor and Council members reported correctly on their reports. He felt there are no violations of the ELEC law or Borough ordinance. They have since cured the matter anyways so there is no longer an issue.

Councilman McCracken asked if inspections are being done by the building department and Code Enforcement. Mr. Kirschenbaum suggested anyone with questions contact Borough Hall as they are being reviewed on a case by case basis.

The Council discussed the Operation Reassurance program and encouraging people to register for it.

Councilman Brennan and Councilman McCracken would like to amend the plastic bag ordinance to also ban plastic straws and Styrofoam similar to what Monmouth Beach did. This would not go into effect until November 2021. Mr. Dasti will prepare an ordinance.

Mayor Walsifer stated we will be seeking request for proposals for ATM services at the beach. It is a convenience for beach goers when the credit card machines are not working properly.

Mr. Kirschenbaum replied no. Councilman Carvelli suggested he keep an eye on our website for more details as they become available.

Maria Rondinaro, 1246 Pinetree, agreed with Councilman Brennan about reaching out to neighbors in need. Mayor Walsifer explained the Operation Reassurance program.

John Walsh, 11th Avenue, asked why the Facebook group Everything Belmar was removed. Mr. Kirschenbaum stated there were too many Facebook pages. All information from the Borough will go through the one page and our website in an effort to consolidate information.

Councilman Brennan asked if there is another way for people to communicate. Mr. Kirschenbaum stated he would prefer people contact the Borough directly with questions to ensure misinformation isn't given out.

Mr. Walsh liked the Facebook group because he could post to it and communicate with other residents.

Beth Rotchford, 1200 Bayview, stated there is a tree in front of her home that might be dead and wanted to know if it's her responsibility to fix the curb. Mike Campbell, Director of Public Works, will look into it.

Councilman McCracken asked how many people participated in the online version of the meeting. John Sabia, Multimedia Director, stated there were 40 attendees.

Gene Creamer, 4th Avenue, stated he would like to see the west side of Ocean Avenue have paid parking because there used to be meters there. He also suggested there be paid parking in the marina. Mayor Walsifer stated we will be reviewing all parking areas and coming up with a plan.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Councilwoman Wann and approved unanimously.
