MOMENT OF SILENCE: Our troops and their families and healthcare workers

WORKSHOP DISCUSSION:

Mayor Walsifer stated there is a bond ordinance on the agenda for the purchase of a new fire truck. It is a demo model, so we are saving a lot of money. Ryan Dullea, Fire Marshall, stated he did a review of all the fire apparatus. The last fire truck was purchased in 2008 and prior to that was 2002. In 2011 a 22-year-old truck was purchased which is now 31 years old. The truck comes ready with just a few modifications. Should be in service sometime in July. Councilman Carvelli asked how much it will cost to fit it out. Mr. Dullea replied \$25,000. He added he is in looking into options for the old truck such as selling for scrap or repurposing it. Mayor Walsifer stated we are also looking to Lake Como to share some cost because of the shared service agreement.

Mr. Kirschenbaum stated we are working on a plan for the bars and restaurants but waiting for the guidelines from the State. Councilman McCracken stated some restaurants have more room for outdoor dining than others and hopes we can work with them to give more space. Councilwoman Wann was concerned about lines forming.

Councilman Carvelli asked how the beach is working out. Mr. Kirschenbaum stated our plan is working very well. Some beaches were closed down this past weekend and people were asked to move.

Mayor Walsifer stated the 507 former Salt license is being transferred to Flames. They will then put their current seasonal license in pocket.

Councilman Brennan asked about the Finance Committee. Mayor Walsifer explained they will sit down and review the budget and make recommendations.

Councilman McCracken asked how much money we hope to receive the from the County. Mayor Walsifer stated the staff has been keeping a list of all purchases and we will submit them to the County for funding. If it is not funded, we will then submit to FEMA.

Councilman Carvelli asked about the 12th Avenue paving. Mr. Kirschenbaum stated they are finishing up tomorrow and then will be moving onto the next phase.

<u>APPROVAL OF MINUTES</u>: Councilwoman Wann made a motion to approve the minutes of the May 19, 2020 meeting, which was seconded by Councilman Brennan and approved unanimously.

<u>REPORTS OF COUNCIL:</u>

Councilman Carvelli: Harbor Commission might meet next week. Everyone is doing a great job. Hopes to get back to normal sooner rather than later.

Councilman McCracken: There are no cases of COVID-19 in the Housing Authority building. Shade Tree Commission meets on the 17th. They are reviewing the current ordinance. Asked everyone to keep victims of violence, healthcare workers and first responders in your prayers.

Councilwoman Wann: Community Policing has met. They created two zones for the south end of town. Thanked everyone who worked on the beach.

Councilman Brennan: Recycling center is open. Environmental Commission is looking into the quality of the water at Silver Lake and how to get certain grass to grow that attracts swans. He saw firsthand the beach plan and it worked great. Friendship Force also worked really well. Drone pics confirm how well the plan is working. People were good at social distancing.

Mayor Walsifer: Everyone has been stepping up. Surprised to see how many people are social distancing on the beach. Thanked the Friendship Force for doing a great job. Thanked Gene Cory, Beach Director, for doing a great job. He is officially retired.

<u>PUBLIC SESSION</u>: Public Session on resolutions only on the Agenda. We will continue to have a Public Session at the end of this meeting.

Cheri Russo, 1218 Briarwood Road, was concerned about nepotism on the Finance Committee because John Carvelli is related to Councilman Carvelli. Felt there are other people that would be better for the committee. Mayor Walsifer stated they are not paid positions but volunteers.

Steve Eschbacher, 219 18th Avenue, stated he saw a lady walking in the wrong direction on the boardwalk and spoke to the special police officers and they said it was not their job to enforce. Mr. Kirschenbaum stated there is no ordinance for them to enforce and it is just a suggested lane of traffic to help with social distancing. Chief Scott stated the special officers are told to advise people to stay in the right lanes and will speak to them again.

Cy Reitmeyer, 5th Avenue, asked if the Finance Committee is going to look at the budget. Mayor Walsifer stated they will also look at other issues. Mr. Reitmeyer was concerned that there were not enough members of the public on the committee.

Linda Sharkus, 4th Avenue, stated the Friendship Force saw a lot of bicycles locked to railings on the beach and thought signage directing people to the bike racks would be helpful. Mr. Kirschenbaum stated there are more signs on order.

Councilman McCracken stated there are a lot of new faces working and suggested another training session with the staff. Mayor Walsifer stated the staff had a meeting Memorial Day weekend during one of the rain outs.

Councilman Brennan made a motion to close the public session, which was seconded by Mayor Walsifer and approved unanimously.
