# WORKSHOP DISCUSSION:

Mayor Walsifer stated the Borough bid on the first aid building for the amount it was appraised for. There was a higher bid by Bill Merkler however once it was explained to him the importance of the building for the Borough Mr. Merkler stated he will withdraw his bid.

Mayor Walsifer explained the resolutions for permit parking and paid parking along the railroad tracks. These changes will help the boat owners by J Dock as well as clean up the parking spaces along the railroad.

Mayor Walsifer announced we will be returning to live meetings beginning June 15<sup>th</sup>.

Shade Tree Commission meetings June 16<sup>th</sup>. The Housing Authority meets on the 7<sup>th</sup>.

Public Hearing: Gerald Buccafusco, 409 5<sup>th</sup> Avenue, asked for an explanation of the ordinance in plain language. Mayor Walsifer stated this ordinance is done every year in conjunction with the budget adoption.

Public Hearing: Gene Creamer, 4<sup>th</sup> Avenue, questioned the language. Mayor Walsifer explained the ordinance gives the Borough control of placement and aesthetics. Mr. Creamer felt this ordinance was much better than the previous one. He asked if there are insurance requirements for the neighbors. Mayor Walsifer felt that would be negotiated during the contract review.

Rob Elia, 106 19<sup>th</sup> Avenue, asked if any research has been done on environmental impact. Mr. Varga stated there are laws and cases in other states, but they are not binding in NJ. Mr. Elia questioned why 5G is needed. Mr. Varga stated the law allows for it.

Mark Fitzgerald, Surf Avenue, felt the ordinance is meant to speed up the process for the Mayor and Council and that should be made clear. Mr. Varga stated the ordinance does specify the process and time clock.

Cy Reitmeyer, 5<sup>th</sup> Avenue, asked about the Verizon lawsuit. Mr. Varga stated it is active litigation that can't be discussed.

Councilman Brennan made a motion to close the public hearing, which was seconded by Councilwoman Wann and approved unanimously.

# **PUBLIC SESSION:**

Katrina Clapsis, 1304 B Street, asked what a red tag on a car is for. Mayor Walsifer stated it is a warning. Ms. Clapsis stated there is a spot on the street near her where the yellow is faded and was concerned people will park there.

Cheri Russo, Briarwood Road, asked for the process to reserve the pickleball courts. Mayor Walsifer advised her to contact the Recreation Director. Ms. Russo questioned the budget and why there is no COVID money. Mayor Walsifer stated we haven't received the COVID funds yet. Ms. Russo was disappointed the budget didn't decrease to lower taxes.

Ms. Sharkus, 4<sup>th</sup> Avenue, suggested the 5<sup>th</sup> Ave Chapel might be a good location to do a Park Mobile partnership with. She was concerned about the rentals at 504 and 506 13<sup>th</sup> Avenue. She suggested a community policing meeting with the property owners.

Edward Grimes, Sativa Cross, asked the Mayor and Council to consider permitted medical cannabis dispensaries.

Sarah Tantillo, 505 13<sup>th</sup> Avenue, was concerned about the tenants and violations at 504 and 506 13<sup>th</sup> Avenue.

Jeff King, Eatontown, would also like to see a medical dispensary in Belmar.

Jennifer O'Neill, 500 13<sup>th</sup> Avenue, was concerned about garage and recycling piling up behind 504 and 506 13<sup>th</sup> Avenue.

Jamie Van Saver, Sativa Cross, would like to attend the ADA meetings to advocate for the rights of medical patients.

Denise Tomlinson, 507 13<sup>th</sup> Avenue, was concerned about her quality of life because of 504 13<sup>th</sup> Avenue.

Maria Rondinaro, 1246 Pinetree Way, said John Sabia is doing a fantastic job with the website and social media. She would like to see council meetings be virtual and in person.

Keith Hunsinger, Wall Township, stated Wall Township is banning cannabis but would like to see Belmar permit it because the voters wanted it.

Linda Sharkus, 4<sup>th</sup> Avenue, mentioned the 200 Club awards to the police officers recognized at the Howard Rowland dedication. Mayor Walsifer stated this was for the rescue of a child that got buried in the sand last year.

Cy Reitmeyer, 5<sup>th</sup> Avenue, was concerned about electric bikes doing wheelies on the streets. Chief Scott will look into it. Mr. Reitmeyer discussed his concerns about the tree ordinance and the owners responsibility to maintain the street trees. Mr. Varga explained the ordinance to him.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Mayor Walsifer and approved unanimously.
