## **WORKSHOP DISCUSSION:**

Lorraine Carafa, CFO, explained there is a shortfall in the beach utility due to the bad weather last year. This year's budget needs to be addressed because of the increase in minimum wage. She presented the Council with options on raising the daily badge rate, lowering the age, and raising parking fees for them to consider. Mayor Walsifer asked that everyone think about it, and it will be discussed again at the next meeting.

Mayor Walsifer stated he is sending a letter to the business owners, inviting them to a meeting to discuss the new tourism fee structure and the removal of the SID tax.

Chief Scott stated all sworn officers are now wearing body cameras and community policing is being enhanced.

Mayor Walsifer introduced Billy Musto who is Acting Superintendent of Public Works.
