2022 BUDGET AMENDMENT HEARING:

Ms. Carafa explained the changes to the budget: increase in fuels costs due to inflation, decrease 2021 collection of water/sewer to reflect actual amount, and an increase in surplus due to the mismanagement of Ordinance 2013-11. The auditor's report regarding Ordinance 2013-11 will be posted on the Borough's website. There will still be no tax levy increase.

PUBLIC SESSION:

Randi Brazel, 101 11th Avenue, was thankful for a pothole being fixed and for the fireworks show. Spoke about an issue involving her neighbor at 103 11th Avenue over Fourth of July weekend which the Police Department is aware of. She was concerned about tickets not being issued for illegal fireworks. Chief Scott stated she is aware of the incident and is looking into it further.

Linda Sharkus, 4th Avenue, spoke about a law Governor Christie had put into place about the use of commercial fireworks being a petty disorderly offense and suggested that be put into effect.

Karen Lereah, 102 11th Avenue, spoke about the same incident Ms. Brazel spoke of. She felt there are no consequences for her neighbor.

Art Ammermuller, 106 12th Avenue, stated his daughter's dog was spooked by the same fireworks and ran away but luckily one of the Police Officers caught him.

Amy Penn, 401 11th Avenue, has seen many of the issues Ms. Brazel spoke of.

Mayor Walsifer stated he will look into why summonses were not issued.

Louise Germinaro, 606 North Lake, would like to see something done about the geese at Silver Lake. Mr. Kirschenbaum stated he is looking into bringing a dog back, but DPW is still oiling the eggs. She also asked about road paving on 5th Avenue. Mr. Kirschenbaum stated the Borough engineer is working on a 5–10-year plan for the roads, which will be presented at the next meeting.

Maria Rondinaro, 1246 Pinetree Way, would like to see the signage at River Court moved so it can be seen from both directions on 16th Avenue. People don't realize it's not a through street.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Mayor Walsifer and approved unanimously.
