## **REPORTS OF COUNCIL**

Councilman McCracken: Did a tour of the Historical Society and Union Firehouse. Those volunteers do a fantastic job. Shade Tree is doing a seedling giveaway on Saturday at Taylor Hardware. Arbor Day festivities with the schools are on April 29<sup>th</sup> and May 5<sup>th</sup>.

Councilman Brennan: Harbor Commission working on dock repairs and looking into dredging costs. Environmental Commission looking for a vendor to do demonstrations on electric leaf blowers. Spoke about the tour the E.C. did at Mazza Recycling. May 4<sup>th</sup> plastic bag ban starts statewide.

Mayor Walsifer: May 14<sup>th</sup> and 15<sup>th</sup> is the town wide yard sale. April 30<sup>th</sup> the library will be accepting donations of medical supplies for Ukraine.

## **PUBLIC SESSION:**

Joe McEvoy, 700 Main Street, asked about the Director of Special Operations and what he did when there were no special events. He spoke about when flags need to be put at half-mast. He was concerned about flags being taken down as well. George Komitas, DPW and Mr. Kirschenbaum stated it has always been DPW's policy to remove the flags when there are storms and high winds, so they don't get damaged. He also asked why the Council can't get involved in the 12<sup>th</sup> Avenue project before the Zoning Board. Mr. Varga explained why. He asked Councilman Brennan to look into why he gets blocked from the Belmar Democrats Facebook page.

Gene Creamer, 4<sup>th</sup> Avenue, asked about the homestead rebate. Ms. Claudio stated the notices were mailed today. He thanked Ms. Claudio for providing him with a copy of Cablevision's insurance via OPRA. Thanked Officer Jones for helping him when Cablevision tried to access his property. Thanked Billy Musto of DPW for answering his question at the last meeting about fluoride in the water, which there is none. He suggested adding a line item to the tax bill to help offset costs for fire and EMS.

Katrina Clapsis, B Street, Historical Society tour was really cool. Suggested the Council hold a meeting at Union Fire House for the 150<sup>th</sup> Anniversary.

Louise Germinaro, 606 North Lake, asked about repaving 8<sup>th</sup> Avenue and the geese mess along the lake. Mayor Walsifer explained the engineer is working on a road plan. Councilman Brennan and Mr. Kirschenbaum explained what the town can do about the geese.

Mark Pfeiffer, 319 5<sup>th</sup> Avenue, asked if 9-1-1 calls go to Belmar or the County. Mayor Walsifer stated they come to Belmar.

Councilman Brennan made a motion to close the public session and adjourn the meeting, which was seconded by Mayor Walsifer and approved unanimously.
