Mr. Kirshenbaum referenced the skatepark presentation at the last meeting. He is working with Bob Losito from the Skateboard shop on some new designs to allow for beginner users to use the skatepark. He is also working on a Green Acres grant application for the skatepark.

Ms. Carafa spoke about the \$377,000 the Borough will be receiving from FEMA for Hurricane Sandy projects.

PUBLIC SESSION:

Anthony Ferraro, Spring Lake, stated he is blind and uses the skatepark. It is a safe place for him to go on his own. He is glad to see progress on it and offered to help.

Tom Dilberger, 1000 River Road, felt the skatepark could have been left open. Spoke about David Hallman being hired at the Library. He felt the Library needs an electronic sign.

Jane Salmon, Wall Township, spoke about the progress of the skatepark. Suggested looking into Green Acres funding. Asked when another presentation will be done.

Mr. Kirschenbaum stated he is working on it. Mayor Walsifer stated there will be public input at it goes out to bid and concepts are submitted.

Ms. Salmon suggested making the skatepark ADA compliant. Mayor Walsifer stated it is a requirement.

Ellen Zavian, 217 9th Avenue, felt addressing ADA and environmental concerns at the skatepark in a grant application would make it move to the top. She asked why the Recreation Committee meetings are not open to the public. Mr. Kirschenbaum stated they are an advisory committee. Mr. Varga suggested she review the borough ordinance and Title 40.

Sharon Mahoney, 800 Main Street, stated there is a discrepancy on Main Street with the speed limit signs. She

was concerned about double parking at 8th and Main Street for the businesses. She asked for an update on bike fixing stations and bike sharrows. Mr. Kirschenbaum stated he is working on the fixing stations and the County and State DOT don't believe bike sharrows would work in Belmar. She spoke about a missing sign at Silver Lake and 5th and North Lake. She would like to see a stop sign at 5th and E Street. Mr. Kirschenbaum stated Chief Scott does not recommend a stop sign be put there.

Kyle Rizzitello, 14th Avenue, Thanked DPW for helping her with a plumbing issue. Thanked Mayor and Council for allowing Belmar Cares to sell snacks at the movie on the beach. Spoke about the importance of the new building for the fire and first aid at 12th and Main Street. She felt this administration is doing a lot of work to better the town.

Bruce Blattner, 407 9th Avenue, asked if the Borough is responsible for his water service from the curb to the house. Mayor Walsifer replied no.

Jesse M., 1202 D Street, was excited to hear about the skate park. It's not just for kids, adults use it too. Felt it is important to get feedback from the community.

John Newberry, Wall Township, was thankful for keeping the skatepark alive.

Kyle Jones, 412 11th Avenue, was thankful for bringing the skatepark back and improving it.

Kelly Ferraro, Spring Lake, suggested memorial plaques at the skatepark for a fundraising event.

Councilman Carvelli made a motion to close the public session and adjourn the meeting, which was seconded by Mayor Walsifer and approved unanimously.
