**ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF BELMAR, COUNTY OF MONMOUTH, STATE OF NEW
JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 19 OF THE
BOROUGH CODE ENTITLED “TRAFFIC”, IN PARTICULAR SECTION
19-12 (PARKING TIME LIMITED ON CERTAIN STREETS)**

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Belmar, County of Monmouth, State of New Jersey as follows:

SECTION I. In consultation with the Belmar Police Department, the Borough has considered creating two (2) fifteen minute parking spaces on Fifth Avenue, in particular at 500 Main Street and two (2) fifteen minute parking spaces for the last two western angle spaces on the north curb line of 8th Avenue, in front of 700 8th Avenue.

SECTION II. As a result thereof Section 19-12 of the Borough Code entitled “Parking Time Limited on Certain Streets” is hereby amended and supplemented to include the following:

1. Two (2) fifteen minute parking spaces shall be and hereby are created on Fifth Avenue, at 500 Main Street.

2. The aforementioned two (2) fifteen minutes parking spaces shall be and hereby are created for the two last western angle spaces on the north curb line of 8th Avenue fronting 700 8th Avenue.

3. The aforementioned two (2) fifteen minutes parking spaces shall be reserved to fifteen minutes from 10:00 AM to 9:00 PM, seven (7) days per week.

4. Appropriate signage shall be placed by Belmar in front of the four (4) designated parking spaces.

5. Other than as modified hereinabove, all other terms and conditions of the aforementioned Section of the Borough Code shall remain in full force and effect.

SECTION III. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION IV. All ordinances or parts of ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.

SECTION V. This Ordinance shall take effect 20 days after final passage, adoption and publication according to law.

**ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF BELMAR, COUNTY OF MONMOUTH, STATE OF NEW
JERSEY, DELETING IN ITS ENTIRETY CHAPTER XIII OF THE
BOROUGH CODE ENTITLED “INTERLOCAL SERVICES PROGRAM”**

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Belmar, County of Monmouth, State of New Jersey as follows:

SECTION I. Belmar believes that that there is no longer a need for Chapter XIII of the Borough Code entitled “Interlocal Services Program” as a result of more recent legislation adopted by the New Jersey Legislature and signed into law by the government.

SECTION II. Therefore, Chapter XIII of the Borough Code is hereby deleted in its entirety.

SECTION III. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION IV. All ordinances or parts of ordinances inconsistent with or in conflict with the Ordinance are hereby repealed to the extent of such inconsistency.

SECTION V. This Ordinance shall take effect 20 days after final passage, adoption and publication according to law.
