

ORDINANCE 2022-06

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER III TOURISM DEVELOPMENT COMMISSION OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, NEW JERSEY, SECTION 3-6.69, TOURISM FEE ASSESSMENT

WHEREAS, the Borough of Belmar now desires to amend and supplement specific provisions with regards to the Tourism Development Commission of the Borough of Belmar Revised General Ordinances.

WHEREAS, the Mayor and Council of the Borough of Belmar have determined that these changes are necessary and proper to allow the Borough to more efficiently apply and enforce provisions of the Borough's Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Borough of Belmar, County of Monmouth, New Jersey, that Chapter III Tourism Development Commission of the Revised General Ordinances of the Borough of Belmar Revised General Ordinances are hereby amended and supplemented as follows:

SECTION I. Section 3-6.6(a) shall be replaced with the following fee schedule:

- a. The tourism fee assessment imposed on any one (1) license shall be as follows:

Summer Rental, Bed & Breakfast, and Rooming House (One, Two or Three Bedrooms)	\$250 per dwelling unit
Summer Rental, Bed & Breakfast, and Rooming House (Four to Nine Bedrooms)	\$500 per dwelling unit
Summer Rental, Bed & Breakfast, and Rooming House (Ten or more bedrooms)	\$1000 per dwelling unit
Mercantile License – Retail Establishment and Take Out Food Establishment	\$250
Mercantile License – Food Establishment with seating	\$500
Mercantile License – Food Establishment with liquor license/Banquet Facility	\$1000
Mercantile License – Charter Boats	\$250
Hotels/Motels	\$1000
Taxi Owner Licenses	\$250
Taxi Driver Licenses	\$100

The tourism fee assessment is in addition to any other licensing fee required by the Borough.

SECTION II. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

SECTION III. All Ordinances or parts of ordinances inconsistent with or in conflict with the ordinance are hereby repealed to the extent of such inconsistency
