Dear Mayor Walsifer, Council President Brennan, Councilwoman,
Councilmen, and Chief Scott,

Last year, a petition, was requested, to change the direction of Snyder Ave from South to North. A Belmar resident, who does not live on Snyder, initiated the petition. While I am sure the petitioner had a good reason, the affects were not good for the residents, who reside on Snyder.

I came before the Board last year, voicing our neighbors' concerns and was told to gather another petition. While it is almost a year later, it is not without reason. (My family had illness, birth, more illness, strokes, death from Coronavirus and a new baby at any time).

With due respect to the Council, I am submitting the petition to change Snyder Ave back to its original North to South direction.

Most residents, who signed **this** petition, live on Snyder or have **DIRECT** impact to this street change. Some are those that signed the first petition unaware of the impact the change would make. Many of those who signed the first petition did not live on Snyder.

Our many concerns were and continue to be many from the directional change.

- The natural blind spot created from the change, crossing 18th from Snyder (N) is unsafe
- The truck traffic has been increased on Snyder because it's easier to come down North Blvd to 18th then to come east on 18th
- An increase in volume of Uber and taxis on Snyder because it's more convenient to come from North Blvd, increasing back-up traffic on Snyder because they are letting out passengers. Also, the corner 18th /Snyder is now pick up for Uber and taxis.
- Increase volume on all side streets, including 17th, Surf, 19th, 20th and parts of 16th heading to North Blvd.
- The residents on Snyder from 18th south cannot access their homes unless they go to Surf to 19th to Snyder, increasing volume on all streets.

As a result of the re-direction of Synder Ave (from South to North); this is a petition to change the direction of Synder back to its ORIGINAL Southbound direction due to a number of quality of life concerns such as (but not limited to):
 Higher volumes of traffic, hazardous safety concerns (speeding, blowing through stop streets, car driving in the wrong direction), limiting driveway access (due to multiple streets in a row facing north (A & Synder).
