RESOLUTION ADOPTING AND CONFIRMING THE FINDINGS AND DETERMINATION REPORT OF THE SIDEWALK ASSESSMENT COMMISSIONERS WITH RESPECT TO THE 2016-2018 SIDEWALK IMPROVEMENT PROJECT

WHEREAS, pursuant to the provisions of *N.J.S.A.* 40:56-30 the Borough Council of the of the Borough of Belmar, in the County of Monmouth, will consider the Findings and Determination Report of the Sidewalk Assessment Commissioners in connection with and related to the local improvement completed in this Borough under the authority of Bond Ordinance No. 2016-09 and Bond Ordinance No. 2017-20, respectively, of this Borough; and,

WHEREAS, the notices required by *N.J.S.A.* 40:56-30 to be posted and mailed were so posted and mailed in proper time and manner by the Municipal Clerk.

WHEREAS, the said Municipal Clerk has filed her proper affidavit of such posting and mailing and which affidavit is a part of the public record in the proceedings of said local improvement; and

WHEREAS, this governing body has held a public hearing to give all interested persons an opportunity to be heard on any or all of the items, subjects and findings contained in the Finding and Determination Report of the Sidewalk Assessment Commissioners in said local improvement matter and no person has shown any good and sufficient reason why the said Report should not be adopted and confirmed as submitted.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOROUGH COUNCIL OF THE BOROUGH OF BELMAR, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, on this $12^{\rm th}$ day of July, 2022 as follows:

- 1. The Findings and Determination Report of the Sidewalk Assessment Commissioners in relation to and in connection with the completed local improvement made in this Borough under and by authority of Bond Ordinance No. 2016-09 and Bond Ordinance No. 2017-20, respectively, of the Borough is hereby adopted and confirmed without alteration, as authorized by *N.J.S.A.* 40:56-30.
 - 2. The adoption and confirmation of said Report is final and conclusive.
- 3. Pursuant to *N.J.S.A.* 40:56-30, the Municipal Clerk is hereby directed to forthwith deliver to the Municipal Tax Collector
 - (a) A certified copy of said Report of Assessment; and,
 - (b) A certified copy of this Resolution of adoption and confirmation of said report.
- 4. The assessments shall be deemed payable upon delivery to the Borough Tax Collector, as set forth in Paragraph 3. The Tax Collector shall forthwith send out by mail or deliver to the owners of such real estate, bills for such assessment in accordance with the provisions of *N.J.S.A.* 40:55-31. At the option of the owner of the real estate affected by the assessment, the assessment may be paid in full or paid in ten (10) annual equal installments, the balance of said installments to bear interest at the same interest rate as charged upon unpaid real estate taxes in the Borough. The Borough Tax Collector shall properly record the date and amount of each payment on the duplicate as a credit to the taxpayer and shall also enter therein a designation of the property on which the tax was paid, the total amount of the assessment and the interest and penalty charged, all in accordance with the provisions of *N.J.S.A.* 40:56-31. Such information shall be open at all reasonable times to public inspection. The Borough Tax Collector or other tax search officer of this municipality shall furnish a proper municipal lien search on any of the

real estate covered by said liens imposed by reason of said local improvement, provided that the applicant pays the proper fee for such municipal lien search. Each such search shall show the balance then due on the premises in question for both assessment, costs and interest or other penalty as the case may be. Stated otherwise, any assessment may be paid by September 1st, without interest or penalty; but if any assessment is not paid by September 1st interest shall be charged at the same interest rate as charged upon unpaid real estate taxes in this municipality.

- 5. Pursuant to the provision of *N.J.S.A.* 40:56-33, each and every one the assessments for local improvements, together with interest thereon and all costs and charges connected therewith, shall after this confirmation by the governing body of the Borough, be a first lien upon the real estate described in the assessments, paramount to all prior or subsequent alienations and descents of such real estate or encumbrances thereon, except subsequent taxes or assessments.
- 6. The Municipal Clerk shall forthwith send a certified copy of this resolution to Borough Collector of Taxes and Tax Search Officer.
